



ENFORCEMENT GRANT GUIDELINES ACKNOWLEDGEMENT

Purpose of Grant

The Enforcement Grant is a competitive grant that provides funding to South Carolina litter control and law enforcement agencies for the purchase of necessary equipment and training needed to assist with the enforcement of litter laws.

Grant Period

The grant period begins on **January 1**, and ends on **December 31**.

Compliance

In compliance with this grant, each grantee agrees to:

1. Mandatory participation in the Zero Tolerance for Litter Campaign during the month of April.
2. Submit a Zero Tolerance for Litter Campaign report and three (3) interim reports to PalmettoPride.
3. Submit a one-page final summary report on the progress made with the new equipment. Along with the final summary report, a completed expenditure report with receipt copies for items purchased must be submitted. This final report is due no later than **December 31**. Please send the final summary and expenditure reports to the following address:

REPORTING DEADLINES, ZERO TOLERANCE FOR LITTER CAMPAIGN

Under penalties of perjury, I certify that:

General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Future developments. Information about developments affecting Form W-9 (such as legislation enacted after we release it) is at www.irs.gov/fw9.

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following:

- Form 1099-INT (interest earned or paid)
- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)

- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding? on page 2.

By signing the filled-out form, you:

1. Certify that the TIN you are giving is correct (or you are waiting for a number to be issued),
2. Certify that you are not subject to backup withholding, or
3. Claim exemption from backup withholding if you are a U.S. exempt payee. If applicable, you are also certifying that as a U.S. person, your allocable share of any partnership income from a U.S. trade or business is not subject to the withholding tax on foreign partners' share of effectively connected income, and
4. Certify that FATCA code(s) entered on this form (if any) indicating that you are exempt from the FATCA reporting, is correct. See *What is FATCA reporting?* on page 2 for further information.
